- District events use of both in-person and technology. We had multiple speakers, and all members had the opportunity to obtain many of the contact hours required for licensure (as a reminder, this is a licensure year remember to get your contact hours)

- I have had the opportunity to visit multiple Colleges and Universities and speak with students I even went to Slippery Rock and was back on the campus where my college career started (Thanks, Nancy!!)
- Students getting the flavor of involvement by being observers to the board and delegates
- Students represented Pennsylvania at APTA's leadership Congress in Washington DC

#### Legislative Update

On my second day as President, Paul Welk emailed me that my "honeymoon" was over as the Pennsylvania Chiropractor Association submitted legislation to the Pennsylvania House of Representatives. I, and the President of POTA, Chrissey Dreashner, met with the Chiropractor association, and to this point, there has been no further movement on this

Other legislative actions that have kept many of us bustling are;

#### Compact Licensure.

- As of this report, the Governor's office is holding this action back. The rationale is FBI clearance is battier to licensure
- We surveyed all PT/PTA programs in Pennsylvania.
- We had a 90% return rate, and the results are that almost all PT/PTA programs require FBI clearance. This information has been presented to the state agency.

#### SB 485

The legislators requested that we split the direct access portion of the bill so that only dry needling is active.

As of this writing, the bill has cleared the committee and is being considered on the Senate floor.

#### SB 1160/61

Expansion of scope for the athletic trainer

APTA PA has sent letters to the legislators voicing our opposition

As of this report, the bill was voted out of the Senate Consumer Protection and Licensure committee.

We began stakeholder meetings in August.

As of this report, we are working with the legislature on language related to AT scope

APTA PA requests that you consider contacting your Pennsylvania legislators. You are the experts as movement specialists. Please be attentive to updates.

#### **Reimbursement Updates**

Providers accepting Highmark insurance learned of a significant cap on services. APTA PA was provided a 72-hour notice before Highmark notified individual PT/OT/Chiropractor practices

We are actively reaching out to multiple practices and large rehabilitation organizations.

With Jon Moran representing you to APTA, we are assisting a national response to CIGNA's cap of billing codes per session

#### Operation update

- Our membership has slipped during the pandemic if you are speaking to PT/PTAs who let their membership lapse, please review the actions both APTA and APTA PA have done to support the profession
- With the decreased membership, our revenues have also decreased the board recognizes our fiduciary responsibility and is addressing costs during this rebuilding period

As we prepare for our October MovePA meeting at Kalahari Resort Conference Center, we hope to see everyone as we begin to get our lives back to normal. 


## **TREASURER'S REPORT**

hile our organization has experienced membership contraction over the past couple of years, our financial state is resilient. APTA PA strives to fulfill its mission at the association, the profession, and the societal levels. From legislative advocacy, offering the highest quality education during district/SIG meetings and annual conferences for members' professional development, payment, regulatory and advocacy activities addressing PT scope and payment issues, and continued investment in DEI ADAPT Scholarships and Special Olympics.

Year over year, APTA PA realized a 19% reduction in overall revenue in 2021 compared to 2020 (\$448k and \$553k, respectively). Expenses totaled \$535k at the end of 2021 compared to \$388k in 2020, a clear indication of the resumption of planned activities that were postponed or canceled in 2020 due to the pandemic. Total APTA PA assets as of 6.30.22 stood at \$1.188M, a reduction of approx. \$220k compared to the end of 2021 (see fig 1). This reduction in overall asset valuation is primarily due to market performance affecting the value of the investment portfolio, combined with a notable reduction in dues and non-dues revenue for the first half of 2022.

Excluding market performance, through the first half of 2022, APTA PA revenue was \$195k compared to \$254k at the same time in 2021. The investment portfolio depreciated by \$111k and was valued at \$1.043M by the end of Q2 2022. Total expenses in the first half of 2022 were \$219k, with member services accounting for nearly 86 cents on the dollar (Chapter Ops, Governance, Professional Services, Conferences, and Website/Technology Development). The next two figures (Figures 2 and 3) show the breakdown of revenue and expense categories.

While the financial picture of APTA PA looks less bright than in past years, this treasurer remains very confident in the resilience of our organization. This can only be possible through the efforts and volunteer efforts of so many members. It also aided sound decisions by the board to leverage technology and realize some cost savings where possible. For example, the January 2023 board meeting will take place virtually, and the annual newsletter will be made available digitally. These efforts maintain the same level of service and move the organization forward while considering fiscally responsible alternatives. In addition, the APTA PA investment portfolio leverages a balanced strategy using Wellington Index Fund with 50% stock allocation and 50% Bonds/Cash Reserves. This strategy is focused on the long-term financial sustainability of the association in order to serve the members for years to come. With the recent downturn of the market performance, the organization can withstand the reduction in value portfolio while remaining prepared to reap the benefits of return on investment in the long term. This treasurer looks forward to meeting as many members and prospective members as possible during the MovePA conference in Kalahari. In the meantime, I'd like to take this opportunity to renew my gratitude for earning the trust of members by serving as the APTA PA treasurer and being part of this great profession. Onward together, seeking to transform the lives of our patients.



## FREQUENTLY ASKED PRACTICE QUESTIONS: INSIGHT FROM THE PENNSYLVANIA PRACTICE ACT AND APTA SCOPE OF PRACTICE

Physical therapists and physical therapist assistants encounter a myriad of dilemmas and concerns as they provide physical therapy services in their everyday practice. Some of these concerns have obvious answers that can be found in the Pennsylvania Physical Therapy Practice Act 110 PTM - Physical Therapy Practice Act.pdf (pa.gov)1 and accompanying regulations in Chapter 40 49 Pa. Code Chapter 40. State Board Of Physical Therapy (pacodeandbulletin.gov)2, but frequently, there are gray areas with no definitive or obvious answer. Similarly, it is often difficult to find solutions to these dilemmas in APTA documents and publications. This article will address several of the most frequently asked questions from physical therapists, physical therapist assistants, students, and practice managers that were posed to the Practice & Research Committee Chair in the past year.

#### **Physical Therapy Referral FAQs:**

Can a PT evaluate a patient without a referral?

The Practice Act is silent about whether you need a referral to evaluate a patient. Since the law is silent, it would be up to your professional judgment as to whether you evaluate a patient prior to obtaining a physician referral to treat that individual. Other important considerations would be whether the payer for the individual you evaluate would reimburse for that service without a physician referral. For example, Medicare, Medicaid, and Worker's Compensation have requirements related to authorization and payment for their services. Additionally, commercial insurers may have policies requiring referrals to evaluate and treat. You would have to know the plan requirements for the individual patient.

What are the referral requirements to treat a patient?

Section 9 of the PA Practice Act 110 states that a PT cannot treat human ailments except by the referral of an individual licensed as a physician, a physician assistant, or a certified nurse practitioner practicing

pursuant to a collaborative agreement with a physician by a licensed dentist or podiatrist for the treatment of a condition that is within the scope of practice of dentistry or podiatry.

 PTs who have met the criteria and received a Direct Access certificate of authorization may treat a patient without a referral for up to 30 days from the date of the first treatment.

May a physical therapist accept a referral from a nurse midwife?

 If the nurse midwife is a certified nurse practitioner practicing under a collaborative agreement with a physician, they would meet the criteria for referring a patient to a physical therapist. Not all midwives meet the stated criteria. Nurse Midwives who are not certified nurse practitioners or midwives who are not licensed nurses would not meet the criteria to refer a patient for physical therapy services.

May a physical therapist accept a referral from a chiropractor?

 Chiropractors are not authorized to make referrals to physical therapists in Pennsylvania as per the Act 110 regulations.

How frequently must a physical therapy referral be renewed?

Again, the Practice Act is silent and does not specify a timeframe for the renewal of a referral. As stated in a previous question, payers may have requirements related to reimbursement.

#### **PTA Scope of Practice FAQs**

Can a PTA provide treatment to a patient that is being seen under Direct Access?

 The Practice Act is silent on whether you can refer treatment of a Direct Access patient to a PTA. Chapter 40 regulations, Section 40.61 (a) (4) (c) does state, "A certificate holder may not delegate the care of a patient being treated without a referral to a physical therapist who is not a certificate holder."

Is a PTA permitted to perform mobilizations?

Chapter 40 regulations, Section 40.53 (b) states, "A physical therapist may not assign or delegate to a physical therapist assistant.....functions which require the formal education or training and the skill and knowledge of a licensed physical therapist, including the following functions: (7) Mobilization." Additional guidance can be found in APTA's House of Delegates Position Statement, "INTERVENTIONS PERFORMED EXCLUSIVELY BY PHYSICAL THERAPISTS"
 InterventionsPerformedExclusivelyByPTsHOD P06-18-31-36 (apta.org)3, which states, "Selected interventions are performed exclusively by the physical therapist. Such interventions include, but are not limited to, spinal and peripheral joint mobilization/manipulation and dry needling, which are components of manual therapy; and sharp selective debridement, which is a component of wound management."

I am a PTA working in a nursing home. Am I permitted to perform patient screenings?

Chapter 40 regulations, Section 40.53 (e) states, "A physical therapist may not assign or delegate to a physical therapist assistant.....screenings to determine the need for the following: (1) Primary, secondary or tertiary services. (2) Further examination or intervention. (3) Consultation by a physical therapist. (4) Referral to another health care practitioner. Section (f) states, "For purposes of this section, screening is defined as determining the need for further examination or intervention, or both, by a physical therapist or for referral to another health professional."

#### Practice while holding a Temporary License in PA FAQs

Are there any restrictions for a recent physical therapist graduate practicing with a temporary license?

• The Practice Act 110, Section 6 (g) states, "Issuance by the board of a temporary license shall permit the applicant to practice physical therapy only while under the direct on-premises supervision of a licensed physical therapist with at least two years of experience." The same language is included in Chapter 40, Section 40.22.

Can a physical therapist holding a temporary license treat Medicare patients?

• The Medicare regulations <u>CMS Manual System</u>4 state: "a qualified physical therapist (PT) is a person who is licensed, if applicable, as a PT by the state in which he or she is practicing....has graduated from an accredited PT education program and passed a national examination approved by the state in which PT services are provided." The temporarily licensed PT must have graduated **AND** passed their national licensing exam to be permitted to enroll in Medicare and begin treating Medicare beneficiaries. In Pennsylvania, a temporary license is only issued to a therapist who has met the criteria for licensure in PA and is eligible to take the national licensing examination. The temporary license expires upon the failure of the first exam or within six months of the time of issuance. The temporary license converts to a permanent license when the applicant passes the licensing exam. Therefore, the PT holding a current, temporary license in PA would not be eligible to treat Medicare patients until they have passed the licensing examination and are fully licensed PTs.

Does a PT have to co-sign the notes written by a physical therapist holding a temporary license?

• There is no language in the Practice Act or Chapter 40 regulations that require a co-signature for documentation. There may be payer considerations.

#### **Telehealth FAQs**

I am treating a patient via telehealth who is a PA resident but will be out of state for two weeks and wants to continue therapy Can I still provide care via telehealth in this situation?

The APTA website <u>Telehealth in Practice | APTA5</u> has guidelines on the provision of telehealth services across state lines. The guidelines recommend that therapists review the state law and regulations in the state where the patient is temporarily residing, as state laws and regulations differ in their governance over telehealth. As per APTA: "It is commonly accepted that a physical therapist can use telehealth to consult with other physical therapists; however in general, the physical therapist who provides the intervention must be licensed in the state in which the patient is receiving care, known as the originating site. It's best to check your state's licensure and consultation provisions." APTA provides a link to "State Actions Permitting PTs To Provide Telehealth Services"6 <u>https://www.apta.org/your-</u> practice/practice-models-and-settings/telehealth-practice/billing-and-coding/state-actions-permitting-pts-toprovide-telehealth. This link contains a downloadable chart that has state-by-state information specific to telehealth service regulations and links to current state laws, regulations, executive orders, policies, and guidance governing telehealth for physical therapy. Some of the links give information specific to out-of-state licensed PTs' authorization to provide telehealth services to a client in their state.

Can I continue to use telehealth as a method of practice when the Pennsylvania waiver expires?

- The Pennsylvania Department of State <u>Telemedicine FAQs (pa.gov)</u> 7 has issued the following comment on the use of telehealth by licensed healthcare providers, including physical therapists: "There is no statute in Pennsylvania that explicitly authorizes the use or disallowance of telemedicine in Pennsylvania..." and "In general, there is nothing that would prohibit licensees from using telehealth... so long as doing so complies with the standards of acceptable and prevailing ...practice..." PTs and PTAs can find evidence on <u>APTA's Telehealth webpage</u> to support the use of telehealth as an acceptable method of practice delivery that meets the Professional <u>Scope of Practice8</u> criteria. There are numerous articles discussing the use of telehealth, and there is also a certificate course for therapists.
- There is information on the current status of both the national and Pennsylvania Public Health Emergency declarations and waivers specific to telehealth, including a link to a Pennsylvania Department of State position statement posted on the APTA-Pennsylvania website homepage and on the Practice and Research page. Information will be updated as new guidelines are released.

When faced with practice concerns and dilemmas, physical therapists and physical therapist assistants should consider the situation from the jurisdictional, professional, and personal scopes of practice as defined by APTA.

- The jurisdictional or legal scope of practice is articulated in the Pennsylvania Physical Therapy Practice Act 110 and the Chapter 40 regulations. These laws and rules govern the physical therapist's license and the physical therapist assistant's certification to practice in the Commonwealth. The State Board of Physical Therapy is empowered to enforce the tenets of the law and regulations.
- The professional scope of practice, as defined by APTA, "is grounded in the profession's unique body of knowledge, supported by educational preparation, based on a body of evidence, and linked to existing or emerging practice frameworks." Guidance can be found in documents such as the Guide to Physical Therapist Practice, the Standards of Practice, Clinical Practice Guidelines, the Code of Ethics for Physical Therapists, Standards of Ethical Conduct for the Physical Therapist Assistant, and Core Values for the Physical Therapist and Physical Therapist Assistant.
- The personal scope of practice consists of activities for which an individual physical therapist is educated and trained and that he or she is competent to perform. Principle/Standard 6 in the Code of Ethics for the Physical Therapist and Standards of Ethical Conduct for the Physical Therapist Assistant provides recommendations for enhancing expertise and competency through lifelong acquisition and refinement of knowledge, skills, abilities, and professional behaviors. Specifically, this Principle/Standard encourages critical self-assessment and reflection on changes in practice, education, health care delivery, and technology and encourages therapists to evaluate the strength of evidence and applicability of content presented during professional development activities before integrating content or techniques into practice.

In conclusion, the APTA-Pennsylvania Practice and Research Committee is available to answer questions and provide insight, guidance, and references related to practice concerns but is **not permitted to provide legal advice or to interpret the Pennsylvania PT Practice Act.**

## ETHICS COMMITTEE REPORT: WELCOME TO ETHICS 2022

The Ethics Committee is responsible for fostering ethical practice in physical therapy as defined in APTA's Code of Ethics. The committee shall educate the Membership and the public regarding ethical practices in physical therapy, shall provide a visible presence for the Membership, the public, the insurance industry and legislature regarding activities to prevent and curtail unethical practices in physical therapy, and shall be responsible for hearing ethical complaints against members in accordance with APTA's Procedural Document on Disciplinary Action. It is made up of four members with one serving as Chair. Concerns, questions or requests for assistance should be emailed to: ethics@aptapa.org.

## **OVERVIEW OF HEALTHCARE ETHICS**

#### What is healthcare ethics?

Health care ethics (aka "medical ethics" or "bioethics"), at its simplest, is a set of moral principles, beliefs and values that guide us in making decisions about our personal medical care and the medical care of others. At the core of health care ethics is our sense of right and wrong and our beliefs about rights we possess as human beings and duties we owe others. This is often referred to as our "moral compass". Thinking proactively and utilizing reflection in-action and reflection post-action about the ethical aspects of health care decisions helps us make current and future choices that are right, good, fair and just.

#### What are the core principles of healthcare ethics?

Our ethical responsibilities in a given situation depend in part on the nature of the decision and in part on the roles we play. For example, a patient and their family play different roles and we, as healthcare providers, owe different ethical obligations to each stakeholder in the patient's care. In the U.S., four main principles define the ethical duties that health care professionals owe to stakeholders. These include:

Autonomy: to honor the patient's right, in consultation with advisors and family, to make their own decision

Beneficence: to help the patient advance his/her own good

Nonmaleficence: to do no harm

Justice: to be fair and to treat similar cases and stakeholders in similar ways

#### What is decision-making capacity?

Patients with decision-making capacity (DMC) have the right to refuse any treatment, even one that is life-sustaining. They also have the right to choose between treatment options based on the principle of informed consent. Generally, only when a patient lacks DMC does their Advance Directive or health care proxy have a role in medical decision-making. For these reasons, it's very important to determine whether a patient has DMC, which sometimes is a difficult determination to make, especially in cases of delirium or progressive dementia. DMC is not the same as "competence," although those terms are often used interchangeably. Competence is a legal term that is determined by a judge and it is typically an all-or-nothing assessment. In other words, a patient is either competent or incompetent. (All adults are presumed to be competent unless declared otherwise by a judge.) Decision-making capacity, on the other hand, is a clinical determination made by a medical professional in collaboration with the patient. Ethical concerns emerge when the patient cannot participate in the decision-making process.

#### **Right to Refuse Treatment**

Every competent adult has the right to refuse unwanted medical treatment. This is part of the right of every individual to choose and it applies even when refusing treatment means that the person may die. The right to refuse treatment applies to those who cannot make medical decisions for themselves, as well as to those who can; the only difference is how we protect the rights of people who cannot make decisions for themselves. A person might decide against having a recommended treatment for any number of reasons.

Some people for religious reasons do not want to receive blood transfusions. Others decide that they don't want a recom-

mended treatment because it is too risky or expensive or because even if the treatment works, there is little or no chance it will get them back to a quality of life they could enjoy or accept. Many people do not want life-sustaining treatments like ventilators or feeding tubes if these treatments are only going to prolong the dying process.

#### Withholding and Withdrawing Treatment

Thanks to recent breakthroughs in medical science and technology, health care practitioners now have a variety of machines, devices, and treatments available to keep people alive when an important body system stops working properly. Examples include breathing machines, feeding tubes, CPR and dialysis machines. Even medicines like antibiotics sometimes serve as a life-sustaining treatment. These technologies can be true life-savers when used temporarily on a person

## WHAT IS BUSINESS ETHICS?

What Does Business Ethics Mean to Me as a Physical Therapist? Business ethics is the study of appropriate business policies and practices regarding potentially controversial subjects including corporate governance, insider trading, bribery, discrimination, corporate social responsibility, and fiduciary responsibilities. The law often guides business ethics, but at other times business ethics provide a basic guideline that businesses can choose to follow to gain public approval.

 $\cdot$  Business ethics refers to implementing appropriate business

policies and practices with regard to arguably controversial subjects.

• Some issues that come up in a discussion of ethics include corporate governance, insider trading, bribery, discrimination, social responsibility, and fiduciary responsibilities.

• The law usually sets the tone for business ethics, providing a basic guideline that businesses can choose to follow to gain public approval.



• Physical therapists need to be very concerned about business ethics. Depending on our work situation, we may be impacted by corporate governance rules, the trading of equities, hiring rules and regulations, third party and government sponsored insurance billing, purchasing, and financing.

#### Bioethics Glossary (adapted from <a href="https://med.stanford.edu">https://med.stanford.edu</a>)

Animal Rights Advocacy: The moral position which holds that animals other than human can have rights.

**Autonomy:** Self-rule, capacity for mature, uncoerced and therefore mentally competent decision-making; not the same as a liberty or right to choose this or that specific action, since this mental capacity is the prior condition of possibility of any competent decision.

**Beneficence:** doing well by someone; well-meaning intent and behavior.

**Business ethics:** Business ethics is the study of appropriate business policies and practices regarding potentially controversial subjects including corporate governance, insider trading, bribery, discrimination, corporate social responsibility, and fiduciary responsibilities. The law often guides business ethics, but at other times business ethics provide a basic guideline that businesses can choose to follow to gain public approval.

Competence: Capability of a mature person to reason and to choose autonomously.

Complicit Moral Agency: agreement in action or intent between two or more moral agents.

Conflict of Interest: A mind-state of having competing goals or intentions.

Harm Principle: Moral maxim which holds that one is not free to cause harm to others.

Involuntary: That which is imposed upon a person despite that person's objection.

Justice: Fairness or treating all equally.

Justification: Supporting reason for an action or decision which renders it morally acceptable.

Moral Agency: Capability of discerning right and wrong.

**Moral Injury:** Moral injury is the damage done to one's conscience or moral compass when that person perpetrates, witnesses, or fails to prevent acts that transgress one's own moral beliefs, values, or ethical codes of conduct.

**Natural Law:** a source of law that arises out of human nature itself, innate, inborn, and which determines species characteristics, like moral agency or capacity to understand and think.

Non-Voluntary: That which is chosen on behalf of an incompetent person.

Palliative Care: Comfort care for those in pain, pain management, hospice care, etc.

**Physical Sentience:** The capacity to feel physical touch or to experience discomfort/pain.

Rationality: Capability to reason or organize thoughts.

Self-consciousness: Awareness of one's identity, knowledge that one's self endures over time.

**Speciesism:** A moral theory which only applies to humans.

**Social Justice:** Social justice is fairness as it manifests in society. That includes fairness in healthcare, employment, housing, and more. Discrimination and social justice are not compatible.

Supererogatory: Heroic or lofty behavior which goes beyond duty or obligation.

**Utilitarianism:** That moral theory which holds that actions are good or bad depending on their consequences. **Viability:** The physical state of being able to remain alive unattached to another human being.

Virtue: A habit of doing good.

**Voluntary:** That which is chosen freely.

#### Ethics Tickler (the Ethics Committee's response will be found in our next quarterly issue)

You are an outpatient physical therapist working in a private office and a mother comes into your office with a 17-yearold child who is complaining of knee pain which began during a "twisting" incident in a soccer game. Upon entering the treatment room, you ask the boy and his mom for permission to examine the child. You immediately notice multiple dark bruises over both legs. You raise the back of the boy's shirt and you see similar marks on his back. You ask the mother where the bruises came from and she tells you that they are from a procedure she performed on him known as "cao gio," which is also known as "coining." The procedure involves rubbing warm oils or gels on a person's skin with a coin or other flat metal object. The mother explains that cao gio is used to raise out bad blood and improve circulation and healing. When you touch the boy's back with your stethoscope, he winces in pain from the bruises. You debate whether or not you should call Child Protective Services and report the mother.

## **POLITICAL ACTION COMMITTEE REPORT**

It has been an active year legislatively. In January the Chiropractic association introduced an Chiropractor Assistant bill. After a stakeholder meeting between APTA PA and POTA this action has been dormant. Our fourth Trimester proclamation has also been delayed as the sponsor, Senator Muth, has not been attempting to move this through the legislative process. Below please find a timeline of legislative actions we have been monitoring or actively pursuing.

#### SB 1160 & 1161

Expansion of Athletic Trainers' Scope of Practice

#### April 2022

Senators Muth and Baker introduced a Senate Bill (SB 1160 & SB 1161), which will increase an athletic trainer's scope of practice. At the time the bill was introduced, the bill would allow the following:

- Athletic trainers manage and provide care of injuries to any "individual" and not just physically active persons (the legal description for an athlete)
- Athletic trainers to assess, manage, treat, rehab, and recondition all "individuals" (not just physically active persons) (whose conditions are within the professional preparation and education of a licensed athletic trainer) (the legal description for an athlete)

#### June 2022

Senate bill 1160 & 1161 was placed on Consumer Protection & Professional Licensure committee agenda with no stakeholders meeting prior to consideration. This procedure is highly unusual. The bill received a unanimous yes and moved to the Senate.

#### August 26, 2022

APTA PA representatives met with legislative directors for Senator Tomlinson (chair of the licensure committee), Senator Boscolla (minority chair of licensure committee), and Senator Baker (co-maker of the bill). The conversation focused on amending the language that defined the scope of practice for the AT.

#### September 21, 2022

Language within the SB 1160 &1161 was updated prior to the third consideration. While the language changed, in APTA PA and POTA's opinion there was no change in the intent.

#### SB 1160/61 was heard and passed

Next, the bill will now move to the House of Representatives, and if "considered" three times and then subsequently voted upon. If passed, without amendment, it will then move to the Governor for potential signing.

#### \*It is critical that we reach out to our Representatives and express our concern for the public's safety if this bill is passed. Talking points can be found on the ATPA PA website.

#### SB 485

- Dry Needling clarification
- Originally was a combination of Dry Needling (DN) and expansion of direct access



- The bill was moved unanimously from the committee to the Senate floor
- Effective September 21, 2022, SB 485 has had 2 considerations on the Senate floor. As of today, there has been no additional movement
- · If not passed, it will be reintroduced next term

#### **Compact Licensure**

- APTA PA did a survey of all PT/PTA programs in Pennsylvania
  - Overwhelming the PT/PTA programs require FBI clearances for all students
  - This information has been introduced to the Pennsylvania administration
- Multiple professions are also approaching the administration about this action
- The commissioner is updating the computer system and working toward this action

#### Regulations

Pennsylvania State Board of Physical Therapy continues to support the following regulatory changes

- Allowing students to take the NPTE prior to graduation
- Allowing contact hours for the managing of student clinical education

As of the September 2022 SBPT meeting the progress through the regulatory process is approaching the period of public comment in the Pennsylvania Bulletin.

## **PRACTICE & RESEARCH COMMITTEE**

want to begin this report by thanking my Committee members for their diligence in working on the Committee projects that focused on practice, research, and education with the goal of providing meaningful and timely information to our members. Pam Pologruto, Brooke Klatt, Melissa Myers, Tammy Frey, Alex DelPalazzo, Kim Wycnarczuk, and give freely of their time and expertise to bring our projects and initiatives to fruition, and I can't thank them enough! I would also like to acknowledge our new Board Liaison, APTA-President Scott Voshell, for his unwavering support of our projects, his sage advice, and his humor that brought some levity to otherwise serious business meetings.

This year, the Practice & Research Committee again focused on "Transforming Clinical Practice" and "Using Research to Build Clinical Skills." We expanded initiatives begun last year and added new projects designed to focus on our theme. The following is a summary of our projects:

- "Transform Your Clinical Practice: Using Research to Build Clinical Skills." A group of talented speakers presented an 8-hour educational track sponsored by the Practice and Research Committee at the 2021 MovePA Conference. Paul Rockar kicked off the track with an introduction session, "The Research Path: From Start to Finish. This was followed by "Steps to Quickly Find Best Evidence, Interpret & Apply it to Your Patient," presented by Mary Ann Holbe-in-Jenny. Three additional sessions focused on applying specific CPGs in clinical practice: Alex Haddad addressed "Applying the Total Knee CPG in the Clinic." Hallie Zeleznik and colleagues presented "High-Intensity Gait Training to Improve Walking Capacity and Performance Following Stroke and Other Neurologic Injuries" and "How to Use New and Emerging Evidence Based on Lessons Learned from COVID 19 for Practice Changes When No CPGs, Systematic Reviews, or Meta-Analyses Exist". Each session was well attended, and the feedback was excellent.
  - The Committee will sponsor another 8-hour educational track, "Transform Your Clinical Practice: Using Best Evidence to Build Clinical Skills," at the 2022 MovePA Conference in Kalahari. Sessions 1 and 2 are: "Applying the Low Back Pain CPG in the Clinic" by Patricia Crane, PT, DPT, MBA. Board Certified Clinical Orthopedic Specialist, and "Applying the Hip Fracture CPG in the Clinic" presented by Kathleen Kline Mangione, PT, PhD, FAPTA, and Joseph Ladesic, PT, DPT, Board Certified Specialist in Geriatrics and Orthopaedics. The final two sessions, presented by Hallie Zaleznik, PT, DPT, Board Certified Neurologic Clinical Specialist, will address the theme, "Are We Still Underdosing? Session 1 will focus on "Applying Intensity Training Parameters for Healthy Adults and Athletes, Patients with Heart Failure, and Older Adults," and the follow-up session will emphasize "Applying Intensity and Training Parameters for Patients with Neurological Conditions including Stroke, Spinal Cord Injury, MS, and Parkinson's Disease."
- Platform and Poster Presentations: 10 researchers presented Platform Presentations, and 20 presented Poster Presentations at the 2021 MovePA Conference. From these, "Imposter Phenomenon and Ambiguity Tolerance Among Practicing Physical Therapists" received the Best Research Report," "Utilizing the AM-PAC to Determine Physical and Occupational Therapy Frequency of Care for Patients Admitted with Acute CVA" received the Best Special Interest Report, and "Describing Mobility of a 'Happy Hypoxic' Patient" received the Best Case Report Award.

- 2022 Spring Poster Webinar Series: 18 mini-webinar sessions based on abstracts that were presented as platforms and posters at the 2021 MovePA conference provided members and nonmembers an opportunity to earn up to 18 continuing education contact hours.
- **Practice Spotlights:** Six handouts and three videos that address clinical topics are posted as a member benefit on the PRC webpage. There have been over 1700 total page views, providing evidence that this initiative is a valuable member service.
- **Collaboration with Pediatric Special Interest Group:** The Pediatric SIG and PRC are planning a Spring 2023 joint webinar that will address issues and concerns in pediatric physical therapy.
- **Practice Updates:** Weekly updates that address current practice alerts, advocacy requests, new clinical practice guidelines, articles of interest, current courses, podcasts, videos, and special events continue to be posted for members in the APTA-PA Weekly email blast and on the PRC webpage.
- **Practice Alerts:** Updated information on the Pennsylvania Licensing waivers in response to the ongoing Public Health Emergency has been posted on the website and included in email notifications.
- APTA-PA Research Grant: The 2022 APTA-Pennsylvania Research Grant was awarded to Julie M. Orlando for her study, "The Effects on Children and Parents of Educating Parents About Ways to Play with Babies." Michael Steimling, the 2021 Research Grant awardee, completed his study, "The Relationship of Pelvic Floor Muscle Activity and Running Biomechanics in Health Nulliparous Females," and Lindsay Carroll, the 2019 awardee, completed her research, "Validation of the Single Leg Squat Test for Use in Individuals with Chronic Ankle Instability." Both researchers will be presenting their studies as part of the Platform and Poster presentations at the 2022 MovePA Conference.
- APTA Foundation for Physical Therapy Research Collaboration: Ongoing partnership continues with the Foundation for Physical Therapy Research to promote and advertise information on research grants, programs, and opportunities of interest to members. The PRC submitted, and APTA-Pennsylvania Board approved a \$1500 grant to the Foundation for the purpose of funding PODs Scholarships which support research for candidates enrolled in professional doctoral study.
- **Support physical therapy-related research projects:** Survey participation requests that meet the criteria are posted on the PRC webpage to facilitate therapist engagement in ongoing PT research.
- Wellness initiative: Committee members continue to work on the plan to transition the wellness information posted on the website from consumer-oriented information to clinician-oriented information.
- Practice inquiries: PRC Chair continues to respond to inquiries related to practice issues.

In this role, the Payment Specialist serves as a resource, directing members to resources on the APTA and APTA-PA websites surrounding common payment issues impacting physical therapists **We require that you include your APTA-PA member number and member name, or the number of the APTA-PA member you represent with your email.** The Payment Specialists, as needed and appropriate, reach out to payers to discuss payment issues being experienced by our members in an effort to provide a resolution, alert the payer to the issue, and/or assist in rectifying the issues. APTA-PA members are encouraged to reach out to the Payment Specialists on payment and regulatory questions or issues. #### HOW TO KEEP UP WITH REGULATIONS AND PAYMENT ISSUES = PAYMENT BLAST

APTA-PA offers members a value-added benefit to payment and regulatory issues impacting physical therapists. The Payment Committee publishes the PAYMENT BLAST every other Friday as breaking payment, and regulatory changes are announced by various payers. If you are an APTA-PA member, you should be receiving the Payment Blasts automatically in your email.

Never miss an issue: Payment Blasts are also archived on the APTA-PA Payment webpage!

#### APTA-PA PAYMENT WEBPAGE

The APTA-PA Payment Committee and the APTA-PA office regularly update the "Payment" Tab on the APTA-PA webpage, allowing providers to readily find resources and hyperlinks to many of the common payment and regulatory questions experienced by physical therapy providers. The webpage is divided with one section providing common APTA/National, which provides coding, billing, fee schedule, practice, and Medicare policy and another section of the APTA-PA Payment web page provides additional resources regarding PA-specific payers, such as Workers Compensation, PA Auto, Highmark, Aetna, Geisinger, Medicaid, etc.

#### **PAYMENT WEBINAR/SEMINARS**

A perfect storm of personal and professional issues prevented us from putting on our annual Fall Live seminars. At the time of the printing, the Payment Specialists are considering offering a free Payment Town Hall in Q4 2022 for members. Stay tuned for an announcement. Our intention is to return in person in the Spring (usually April) of 2023.

#### **TELEHEALTH PAYMENT UPDATE**

Please Check out the Practice and Research page for information on where PA stands on PT telehealth practice. The Payment Committee will continue to update the Telehealth Payer Chart, which has information on each insurer's policy for telehealth services and payment. On the Federal side, APTA continues to push for the permanent addition of PT/OT to allow providers to be reimbursed for telehealth services. At this time, we can still practice telehealth under Medicare as the Public Health Emergency (PHE) was extended through October. If and when the PHE is ended (by the Secretary of Health and Human Services), telehealth will remain allowable for 151 days.

#### ADVOCACY

We support the APTA-PA efforts both locally and nationally to advocate for PA and national issues, many of which involve payment policy. This year we are facing payment cuts in Home Health and Outpatient. APTA's advocacy to stop the cuts is a priority issue for the Association. The APTA-PA and APTA websites provide resources for members to utilize when contacting their legislators. We encourage members to review these resources when conducting therapy advocacy.

#### FEDERAL PROGRAM UPDATE PTA NEWS

As of Jan 1, 2022, Federal programs (CMS) and Humana commercial and Medicare programs started enforcing the PTA Differential payments. Clinics should be well versed in applying the modifiers at this point and have a plan to cover the payment reduction while still supporting PTA services. As of this writing, Cigna has announced plans to implement the PTA Differential for commercial plans effective Oct 15, 2022. The APTA is actively fighting Cigna's plan and has posted advocacy updates and resources.

**CMS FINAL AND PROPOSED RULES – Please note:** All the Rules summaries are available to members on the APTA webpage. CMS also publishes "Fact Sheets," which summarize the Proposed and Final Rules. The Rules themselves are published in the "Federal Register." Many of the proposed rules are now final; however, we have still published some of the proposed rule highlights as many of these proposals were expected to be in the final rule. Please review the final rules in your area of practice to see what changes are expected in 2023 from CMS.

Summaries of the Proposed and Final Rules are available on the APTA website as well as in Archived Payment Blasts. Rules coming out November 1, including the Home Health and Final Physician Fee Schedule (PFS), will be reviewed in the first Blast following release. We have opted not to post summaries in the newsletter this year since that information is available in depth with just a few clicks on the Association's websites.

Please note the major themes projected in the 2023 Final and Proposed Rules involve payment cuts which the APTA is fighting. An additional advocacy focus is to change OP PTA Supervision under Medicare in Private Practice to "General Supervision," which is allowable under all Federal programs regardless of setting. This does not change PA Practice Act

PTA Supervision regulations which may be more restrictive. As a reminder, you must follow the most restrictive regulation, which may come from the PA Practice Act, State Law/Regulation, Federal Law, or CMS regulation. With Supervision, we recommend you always check the PA Practice Act and Rules first to make sure you are following the most restrictive regulation.

#### 2022 KX MODIFIER AND THRESHOLDS:

Though it is late in the year, we always clarify what is regulation for the KX modifier:

CMS retained the KX modifier but amended the language from "caps" to "thresholds" for 2022. The KX modifier must be applied when the payment reaches \$2150 for combined PT and SLP and \$2150 for OT.

CMS retained the \$3000 threshold for Medical Review.

At the time of publication, the Final PFS rule may be out, and the 2023 threshold amounts, which are indexed to inflation, will be posted. Please check out the Payment Blast, APTA, and APTA-PA webpages for the updates

#### PA MEDICAID

After a relative period of quiet after the state phased in the Community Choice Medicaid program, we have begun to hear of some problems with these managed care Medicaid programs, run by commercial insurances. Highmark Wholecare, formerly Gateway Medicaid, is one of the programs with problems that we have been contacted about. #### **COMMERCIAL INSURER UPDATES**

Where are the Commercial insurers headed? We have been reporting on the move by insurers to have third-party claims management companies take over managing claims processing and the pre-authorization process. We have seen this extended to Home Health as well in 2022. The payers report cost savings as a reason for this implementation, but the bottom line is that there has been an explosion of these companies. This shift has been what we call a "Back to the Future" movement in which we are seeing the administrative burden, especially with pre-authorization, increase, taking us back to regulations we fought so hard to eliminate years ago. In PA, we have seen Magellan, American Specialty Health (ASH), Aim, and others, take over claims management and pre-authorizations. Chapters are fighting back with the support of their members and overturning pre-authorization requirements. Also, there is a bill in US Congress (H.R. 3173/S. 3018) that would reduce the burdens imposed with pre-authorization in Medicare Advantage programs, many of which have a negative impact on timely patient services. Look for more fighting back from the Association in 2023 to combat these changes.

Some brief commercial insurer updates:

#### AETNA

We are still burdened with denials for the 180-day evaluation payment limit, which Aetna re-implemented in 2022, requiring an appeal to be paid. If your appeals are denied for evaluations being conducted and billed with a reason code of 180-day, please contact us at payment@aptapa.org.

#### HIGHMARK

We have been working hard to oppose the recent Highmark payment cut announcement impacting Private Practice clinics, what Highmark calls bundling, which limits payments of 97000 series codes to \$92/day maximum or \$120 if an eval or re-evaluation is done with treatment. At the time of this writing, APTA-PA representatives have been meeting twice a month to formulate and update our plan to fight this policy, take action on our plan, and handle the problems that have occurred with the transition. Please look for updates in the future Payment Blasts.



#### CIGNA

As of this writing, the APTA was fighting Cigna's plan to enact the PTA Differential for commercial plans on October 15, 2022. This applies to only Cigna plans that are not managed by American Specialty Health (ASH). Hopefully, by this publication, that effort was successful in stopping Cigna from rolling out the Differential this year. Cigna has also announced its intention to move to a 4-unit max per day across various plans, although plans managed by ASH already had this limitation.

2023 looks to be a major year of Chapter and member advocacy in payment issues. Your Payment Committee will continue to work towards helping members navigate the difficult maze of payment!



## **DESALES UNIVERSITY**

he 2021-2022 academic year was a pivotal one for successful outcomes and recognition of the DeSales Doctor of Physical Therapy Program. In spring 2022, we submitted a Self-Study report to CAPTE and experienced a positive site visit in June in optimistic anticipation of an affirmative decision for 10-year re-accreditation later this fall. Our 2020 and 2021 graduate classes brought national recognition to the university as one of 19 DPT Programs in the nation with a 2-year, consecutive average of 100% first-time pass rate on the National Physical Therapy Examination. In August 2022, we welcomed our 8th incoming class to our beautiful suburban campus, providing them with an enhanced learning environment in our state-of-the-art clinical simulation center, pristine anatomy laboratory, and newly renovated Will's Hall, featuring a large dedicated DPT classroom, modern student-lounge facility, conference and study spaces, and opportunities to interact with students in the new Speech and Language Pathology program who share this building with us. In the Gambet Center, several inter-professional educational activities were conducted with faculty and students from the Physician Assistant (PA) and nursing programs, with the assistance of faculty-trained standardized patients simulating various musculoskeletal and neurologic cases. As we move forward

into the 2022-2023 academic year, new case scenarios are being developed to include SLP students and faculty. Our dedicated research laboratory facility was enriched by the purchase of Noraxon EMG and 3D motion capture systems, and a new dual DPT/MBA degree program was approved to be launched this fall.

#### SERVICE

Over the past year, the faculty developed a model plan for the DeSales DPT Pro Bono Clinic Network with the goal of providing our students with additional integrated clinical education experiences beyond that which we currently offer in our clinical reasoning curricular track. This fall, we are partnering with Bethlehem Emergency Sheltering to offer pro bono services to the homeless population in Bethlehem and the surrounding community. In the spring of 2023, we anticipate the opening of an on-campus, student-run, faculty/alumni supervised clinic offering physical therapy care to the poor, underserved, and/or underinsured throughout the Lehigh Valley. Working under the supervision of Dr. Stephen Carp, our students continue to work with students and faculty from 11 other universities providing care at the Norristown Immigration clinic. Additionally, a broad spectrum of service-learning





activities was organized and sponsored by the DPT Student Association (DPTSA), addressing food insecurity by preparing meals for soup kitchens and stocking local food pantries, crocheting blankets, and collecting toys for infants and children in the NICU and local hospitals, and supporting Special Olympics, the Miracle League, and numerous community service fund-raisers. The DEI and Minority Affairs committees of the DPTSA coordinated with students from the PA and nursing programs to present several informative webinars raising public awareness about DEI issues in healthcare.

To support the continuing education needs of physical therapists and physical therapist assistants in the region, the program offered a series of on-site CEU courses, including a two-day symposium on caring for patients with limb loss, an APTA Credentialed Clinical Instructor course, an Academy of Pelvic Health course, and a cadaveric anatomy course on the wrist and hand presented by DPT faculty members, Dr. Christos Karagiannopoulos and Dr. Cameron Bassett. A Certified Stroke Rehabilitation Specialist course, another cadaver anatomy course on the back, and a level-one Academy of Pelvic Health course are scheduled for this fall.

#### RESEARCH

Faculty and students also accomplished a number of research-initiative outcomes. Our students excelled in their 3-year research curriculum, with 100% of their projects and case history reports disseminated at our Annual Research Symposium in October 2021. Several faculty-mentored student projects were presented as posters or platforms at the MovePA Annual Conference, with one receiving the award for the best research project, and several others were accepted for APTA Combined Sections Meeting in San Antonio.

All DPT faculty contributed to the body of knowledge through conference presentations or distinct publications in various primary sources. Dr. Sean Griech and colleague Dr. Julie Skrzat were co-editors and co-authors of a book entitled *Case Studies Across the Continuum: A Physical*

Therapist's Perspective, in which some of our other faculty contributed chapters, including Dr. Ethan Hood (on CVA from atrial fibrillation), Dr. Stephen Carp (on normal pressure hydrocephalus), and Dr. Suzanne Migliore and coauthor Dr. Karen Warenius (on cerebral palsy). Dr. Christos Karagiannopoulos co-authored an article with Dr. Griech and Dr. Brian Leggin that was published in the International Journal of Sports Physical Therapy. He also contributed a chapter on proprioception re-education in a book on rehabilitation of the hand and wrist and co-authored the latest AAOA Clinical Practice Guidelines on the Management of Distal Radius Fractures. Dr. Stephen Carp contributed a chapter entitled "COVID-19 and the Future of Healthcare" in Yes, Francis. Ways to Help in the Post-Pandemic World, and his student research group had an abstract published in the International Journal of the Alzheimer's Association. Dr. Ethan Hood co-authored an article with colleague Dr. Dennis Klima for Topics in Geriatric Rehabilitation on post-stroke effects on power production. Along with the book and journal article previously mentioned, Dr. Sean Griech also published with colleague Dr. Todd Davenport in Cardiopulmonary Physical Therapy Journal. Clinical Associate faculty, Dr. Stephen Kareha, co-authored an article in the Journal of Osteopathic Medicine on a novel movement system screen for primary care providers. New faculty member Dr. Cameron Bassett successfully defended his doctoral dissertation and presented a poster on obturator nerve neurodynamics at the American Association of Clinical Anatomists conference. Dr. Jennifer Howanitz and Dr. Kay Malek have faculty-mentored student projects that will be presented as posters at the Education Leadership Conference in October in Milwaukee.

#### **EqUIPT Program**

Neumann University was one of the physical therapy programs to receive funding from the American Physical Therapy Association – PA to improve minority representation in both physical therapy schools and the Physical Therapy profession. To address this challenge, the Physical Therapy Program at Neumann University developed the EqUIPT Program, Equity for the Under-Represented in Physical Therapy. The EqUIPT Program has started several initiatives to achieve its goals of increasing the percentage of minority students in the program and improving the retention of these students.

First, a program of peer mentoring was created to match current students with alumni. Students connected with alumni through online meetings and informal gatherings. Then each student chose a mentor who could assist with not only studying strategies but also navigating the difficulties of an intense academic program.

Second, a peer tutoring program was created where upperclassmen held multiple online review sessions for students currently enrolled in some of the more challenging courses in the curriculum, including gross anatomy and neuroscience. Participation in these review sessions led to improved performance for the students but also improved the level of comfort with the material for the tutors.

Finally, a summer scholar program was created to help better prepare a minority undergraduate student or a recent graduate for the rigors of post-graduate education. The scholarship allows the candidate to participate in the biomechanics & kinesiology course as well as portions of the gross anatomy course. It also provides a peer mentor, support in studying for the GRE, and support in applying to a physical therapy program in the upcoming year. The first summer scholar for Neumann University was Shannon Nixon. Shannon completed her courses this summer and is in the process of applying to physical therapy programs for the 2023 calendar year.

#### **APTA Pennsylvania 2022 Fall Newsletter**

The Pennsylvania College of Technology Physical Therapist Assistant students had a busy academic year in the classroom and in the community. Last spring, the Penn College PTA and Nursing programs collaborated to create an Interprofessional Education (IPE) experience for students. The IPE is centered on the treatment of patients who have had a stroke. The faculty developed a case scenario about a mock patient who had a CVA, and students worked in small groups to have thoughtful discussions led by facilitators. Nursing students provided a presentation regarding the medical management of the patient, while PTA students demonstrated and instructed nursing students on safe bed mobility, transfers, and gait training. The successful IPE focused on teamwork, roles and responsibilities, communication, and the importance of collaborative interdisciplinary healthcare.

For the second year in a row, second-year students provided their rehabilitation research poster presentations

virtually during the April 2022 APTA Pennsylvania Northcentral District meeting. This year's meeting had over 40 registrants, and the participants were able to earn free continuing education units for viewing the live presentations. Poster topics included physical therapy interventions for patients with amputees, chronic pain, and cardiopulmonary issues. The students' posters and prepared remarks were expertly produced and broadcast via webinar by Penn College instructional media specialists.

Alumnus Mary Kathleen (Katie) Bunn was the keynote speaker for the Pledge Ceremony who spoke on the meaning of professionalism in physical therapy practice.



The Advanced Vestibular Rehabilitation Certificate program graduated its first cohort of 58 people from the US and five additional countries. In August, the Pitt DPT program will welcome the DPT Class of December 2024, which

includes 60 students in the residential and 90 students in the hybrid option of the DPT program.

We launched the ADaPT@Pitt (Advancing Diversity in Physical Therapy) program, which is a pipeline program to inform under-represented minorities of career opportunities in physical therapy and to help make under-represented applicants to the DPT program more competitive. With the support of a grant from APTA – PA, the first ADaPT@Pitt Summer Scholars Program was held this summer from June 5th to 10th for 12 under-represented minority undergraduate students, during which they were immersed in on-campus experiential learning experiences to introduce them to opportunities in physical therapy and to provide career development advice to be a competitive applicant for a DPT program.

#### New Learning Spaces and Opportunities for Interprofessional Collaboration

Interprofessional learning <<u>https://www.widener.edu/news/news-archive/future-wideners-health-science-programs-bright-and-integrated</u>> at Widener is taking the tried and true practice to a new level with the expansion of health science programs in the College of Health & Human Services (CHHS) as well as investments in campus facilities. Since 2019, CHHS has launched the occupational therapy doctoral (OTD) and speech-language pathology (SLP) master's programs to its roster of powerhouse programs, which includes the nationally recognized DPT program. At Widener, interprofessional learning and engagement are built into students' academic careers at multiple levels, both academically and clinically, starting from day one.

This fall, students in the PT, OT, and SLP are being greeted by four state-of-the-art clinical laboratories, a clinical anatomy lab, six classrooms, three student gathering areas, and an administrative suite for program leaders. Most importantly, they will find an environment built to reflect the collaborative nature of their fields and the interprofessional approach to health sciences education that Widener has pioneered. The vision for the new learning spaces <<u>https://www.widener.edu/news/news-archive/breaking-down-silos-and-walls-create-collaborative-health-sciences></u> was driven, in part,

\$6 million in research funding in Fiscal Year 2022. New grants received by faculty in the Department of Physical Therapy this year included a grant from NIH/National Institute of Aging to investigate the effectiveness of the On the Move group exercise program to improve mobility in community-dwelling older adults (PI Brach, total amount of the award \$3 million), a grant from NIH/ National Institute of Child and Human Development -National Center for Medical Rehabilitation Research to assess access to and effectiveness of community-based rehabilitation after stroke (PI Freburger, total amount of the award \$3.9 million), and a trial to inform a precision medicine approach for the treatment of chronic low back pain that compares acceptance and commitment therapy, duloxetine, enhanced self-care, and evidence-based exercise and manual therapy (PI Piva, Sowa, and Wasan; the total amount of award \$1.4 million). Additionally, two faculty received K23 Career Development grants, including Dr. Brooke Klatt for a project entitled "Factors Associated with Activity and Participation in Vestibulopathy" and Dr. Andrew Sprague for a project entitled "Graft Harvest as a Model of Tendon Injury - Trajectory of Recovery and Clinical Outcomes." Dr. George E. Carvell, PT, retired in January of 2022, which was a loss to all of us who have learned and worked with him over his 45+ years at Pitt. We wish him only the best and hope to continue to engage his brilliant mind in moving our profession forward.


